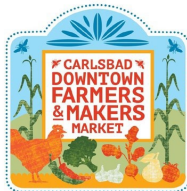

**Please note that the courthouse lawn now has a map with numbered vendor locations. Since the Farmers & Makers Market operates on a first-come, first-served basis, each vendor will be assigned a location number upon setup. Vendors must remain within the booth size they have paid for (e.g., a 10x10 space if that is what was purchased).**

**All vendors are required to complete the check-in process upon arrival. This helps the Vendor Coordinator accurately track who is participating in the Market and what location has been assigned. The check-in will also include scanning a QR code for recordkeeping purposes.**

**Your assigned location number will also be required when reporting sales through the provided QR code after each market. Reporting sales is mandatory. If sales are not reported after three reminders, you will no longer be permitted to set up at the Farmers & Makers Market for the remainder of that session, and any payments already submitted will be non-refundable.**
